Proposed project and the expenditure of funds may be used for construction costs of a manufacturing facility, and utilities related to the same. Total of all project incentives and the expenditure of funds not to exceed \$205,000.00.
 8. **PUBLIC HEARING:** The SEDC will receive comments for proposed project and the expenditure of funds for the Maass Flanges Project to promote new or expanded business development. Proposed project and the expenditure of funds may be used for construction costs of an industrial facility and utilities, infrastructure, permits, and improvement needs related to the same. Total of all project incentives and the expenditure of funds not to exceed \$205,000.


