

SEDC Monthly Updates now Include Sales Tax Reporting



125 2nd Street Property

The City of Sealy recently demolished the secondary building at 125 2nd Street. The SEDC Board deliberated on the future of the remaining primary building.



It was determined that the optimal course of action would be selling and relocating the building from its current site. This decision was made with the recognition that removing the building would facilitate the creation of additional parking spaces. In early May, the Sealy EDC issued a notice in the Sealy News inviting sealed proposals from potential buyers interested in purchasing and relocating the building. Two house moving companies were notified of the bidding process. Furthermore, the Sealy EDC is expanding it's outreach by establishing a presence on Facebook and the SEDC website to circulate the notice. One house moving company did already look at the property to prepare a proposal.

As a reminder, this project will increase critically needed parking of the downtown area to enhance patrons convenience when visiting local businesses.

Hill Center Parking

The SEDC has been informed of a potential need to revise the comprehensive drainage plan for the Mark A. Chapman Park and the surrounding area. City Leadership has advised the SEDC to suspend progress on the Hill Center project until the drainage plan is reassessed. This pause allows for the simultaneous implementation of projects which include the EDC's parking expansion and the city's drainage project. Concurrent projects could result in cost savings for both projects through economies of scale.

Hill Center Parking Continued

The proposed parking expansion represents a significant increase in spaces tackling several problems for the community. It addresses challenges from the current growth in population and the increasing popularity of the park and community center with respective activities. During the March meeting, the EDC Board voted to prioritize the construction of the expanded parking at the Hill Center with the first phase in the improvements to the Mark A. Chapman Park drainage.

Going forward, the EDC will maintain oversight with the project's advancement and ensure regular updates are provided. Once the EDC is able to start the project, the first step will be seeking SEDC Board approval for a task order and probable cost estimation for the parking project. The engineering task order, to be provided by Strand Associates, will outline the comprehensive plan and provide a projection of the associated costs for the project. The W.E. Hill Community Parking expansion project was identified as an SEDC priority for 2024.

Budget Amendments

During the April 23, 2024 EDC Meeting, the Board of Directors discussed the proposed SEDC budget amendments. The Board expressed gratitude to staff for aligning with the directives outlined in the 2024 EDC Strategic Plan concerning the proposed amendments. The proposed budget amendments address SEDC priorities regarding preliminary engineering and probable cost needed for Downtown Parking and the W.E. Hill Community Center parking expansion, the land lease for downtown parking on railroad owned land, the final Retail Coach Consulting payment, and other incidental amendments to cover the expenses relating to the existing SIKA and Prasek's Project payments for 380 agreements, the rental payments for the SEDC new meeting room, and funding for our telephone services.

The SEDC amendments were proposed to the Sealy EDC Board in April, and the City Council during their May 9th meeting. The amendments were approved.



Cryan Park Pond

The Jacqueline A. Cryan Park Pond is being evaluated regarding design and capacity. The study will help determine a path forward for cleaning and sculpting the pond's banks. In addition, the pond and the area around it are being evaluated for a future project to provide lighting in the park for walkers to enjoy Cryan Park and all it's current and future amenities.





SEDC Office Expansion

The SEDC's new meeting space is now operational. After the space received a fresh coat of paint, new baseboard trim, and new carpeting, the City's Streets and Parks Department generously assisted in relocating our large conference table and chairs to Suite #5 of the Professional Building. Since then, SEDC staff has already conducted two meetings in the space. Efforts are underway to collaborate with Blue Iron Technologies to establish an internet connection and install a wall monitor with wireless capabilities. This process may take about a month to complete. It is anticipated that the Sealy EDC Board of Directors will convene for the May Meeting in the newly added suite.

The Medrano Project

Sealy EDC received a facade improvement application for a multi business project. The project is located at 416 HWY 90 West in Sealy. The building owners, the Medrano's, were recently cited for code violations for some of their structures on the property. In response, the building owners have taken proactive steps not only to rectify these violations, but also to provide additional improvements. The comprehensive improvements will include the addition of a bathroom, a new facade to the storage units, interior upgrades to the storage units, new roof, expanding the awing over the car detailing business, and touch up painting for the previous Ella Bella building. The Historic District and Business Improvement Grant will only provide a 50% match up to \$11,000.00 for two items, the facade and an ADA compliant bathroom. Staff will bring the project to the SEDC Board of Directors during the May meeting. Below are pictures of the current state of the project, and the proposed after picture.

Retail Coach/EDC Partnership

Sealy EDC staff is gearing up for further collaboration with The Retail Coach. The Retail Coach will be representing Sealy, TX at the International Council of Shopping Centers Retail Conference in Las Vegas this month. During the event, Retail Coach representatives have scheduled meetings with retail developers. Some first-phase interest has already come from selected retailers who have requested additional information about Sealy. Sealy EDC staff will follow up with the Retail Coach at the end of May and receive updates regarding further interest and developments.

This month, the new market data provided by Retail Coach will be used to enhance our SEDC outreach. In our collaboration with the Greater Sealy Area Chamber of Commerce, two pages of content will be featured in the Chamber's annual periodical, and one of the two pages will feature this new market data.

Looking ahead, Retail Coach will assist us in utilizing their online software platform for real-time updates on retail recruitment progress and retailer responses. The platform will provide us with invaluable insights to drive our efforts forward.

Professional Building has generously
presented the SEDC with exterior lighting for
our signage. This lighting designed in the
style of solar down lighting, illuminates only
during nighttime hours. It will enhance the
visibility of our office for travelers during
evening hours and provide additional
lighting for attendees during SEDC evening
meetings.



Sealy EDC Website Updates

This month EDC staff committed to steadily improving the Sealy EDC website. Over the coming months, all sections of the website are expected to undergo updates and improvements. These enhancements will focus on strengthening Sealy's connection to our target markets and ensuring that our market data remains current and the page remains operational. The approach involves systematically completing one page at a time. The improvement efforts are starting with the "Sealy Advantage Page", which is a link on the website's landing page. Sealy's greatest advantage is its location. Positioned within the Texas Triangle Region, with proximity to airports, seaports, higher education institutions, and metroplexes, Sealy is an ideal location for manufacturing and distribution. A comprehensive page highlighting the benefits of Sealy's location in relation to the transportation industry is currently under development and will be available for Board Review by the end of May. Subsequent pages will continue to showcase other advantages of Sealy in the near future.

Sealy - Texas Sign Improvement

The Sealy Texas Sign project is slated to start by the end of May 2024. Sealy EDC is working with City staff and Master Gardener, Renee Kofman to enhance this iconic area. The project was approved by the SEDC Board in March 2024 and subsequently by the Sealy City Council in April. Since then, the project has been on hold due to the 60-day waiting period following the public notice. The waiting period will conclude at the end of May. The project encompasses several improvements including enhanced landscaping, flag lighting, and fresh paint on the letters spelling out SEALY - TEXAS. SEDC will coordinate with our partner's schedules anticipating the project's completion in May or early June 2024. The project serves as a cost effective and preliminary step in improving the area before the projected TXDot projects begin in 4-5 years.


Dallas Federal Reserve Texas Economic Performance & and Outlook (April 2024) "Employment Growth Slows"


- Texas employment rose 1.6 percent in March, slower than February's 4.1 percent increase.
- Texas job growth grew slower the nation's 2.3 percent rise in March.
- The Dallas Fed's Texas Employment Forecast indicates jobs will increase by 2.3 percent in 2024.
- Forecast was 2.5 percent job growth this year.
- Year-to-date Texas employment growth was 2.5 percent greater than U.S. (2.1 percent)
- Texas unemployment held steady at 3.9 percent in March.
- U.S. unemployment rate ticked down to 3.8 percent in March.
- March Texas Business Outlook Surveys (TBOS) show improvement in the service sector but contracting manufacturing activity.
- Texas firms report a slowdown in the growth of prices and wages over the next 12 months.
- Over the next six months, Texas firms are concerned by weakening demand, potential recession, and domestic policy uncertainty


The economic outlook for the Houston region can be summarized as follows:


- Job Growth: In Q1 2024, Houston's job growth was 1.9%, which is slower than the state average of 2.5% and the national average of 2.1%. This indicates that Houston's job market is growing at a slower pace compared to the state and national levels.
- Unemployment Rate: The unemployment rate in Texas held steady at 3.9% in March 2024, which is the same as the national average. However, the document does not provide specific information about the unemployment rate in the Houston region.
- Manufacturing Activity: The document mentions that manufacturing activity in Texas turned negative in March 2024. While it does not provide specific data for Houston, it suggests that the manufacturing sector in the region may be contracting.
- Housing Market: The document indicates that Texas home sales and housing permits are on the rise, while
 mortgage rates have flattened. However, it does not provide specific data for the Houston region.



















Retail industry rose 6%

Collections from the Retail industry grew \$6,967 in February, an increase of 5.96%. For the year, Retail is up \$14,178, or 2.1%.

The table below shows taxpayers with the biggest increases.

Wholesale industry rose 52%

Collections from the Wholesale industry grew \$6,123 in February, an increase of 51.55%. For the year, Wholesale is up \$24,180, or 50.7%.

Manufacturing industry dropped 31%

Collections from the Manufacturing industry fell \$6,190 in February, a decline of 31.34%. For the year, Manufacturing is down \$60,338, or 40.1%.

The table below shows taxpayers with the biggest declines.


Top taxpayers grew 37% in February

Your top 10 taxpayers in the month of February combined for \$92,283, or 36.0% of your total collections. That represents an increase of \$24,949.25, or 37.05%



Over the past 10 years, collections through February have, on average, represented between 34.2% and 44.1% of your end-of-year collections. Based on your FYTD collections through February and historical collection data, you should reasonably be able to expect end-of-year revenue to fall between \$3,070,380 and \$3,960,710. Last year you collected \$3,359,254.

The chart below shows our end-of-year projections based on each month that has passed so far this fiscal year.



This is a simple weighted forecast. It compares the fiscal year to date totals for each morah with the ending collections amount to estimate whist percentage of revenue had been collected up to that point. Using several years of historical data (weighting recent years more heavily), you can project your end of year totals within a reasonable range of confidence. As the year progresses, the forecast will grow more accurate. The main limitation with this methodology is it does not account for major new taxpayers that may come online later in the current year.
